WAIVER

EVERY PARTICIPANT IN THE PENINSULA REINING CLUB'S ROCK SLIDE (CALLED THE SHOW) SHALL CAREFULLY READ THIS NOTICE BEFORE SIGNING.

No participant will be allowed to enter the arena or compete prior to reading and signing this form.

To: The Peninsula Reining Club *Rock Slide* Show Committee, and the Western Canadian Reining Association
Their representatives, agents, officials, volunteers, business operators, and property owners (all of them collectively called the HOST)

I, _____ (Participant) am aware and understand that there are inherent Dangers, Hazards, and Risks (collectively called Risks) associated with Equine Activities. These inherent Risks of Equine Activities means those dangerous conditions that are an integral part of Equine Activities, including but not limited to:

1. The propensity of any equine to behave in ways that may result in injury, harm or death to persons on or around them and/or danger to property in their vicinity;
2. The unpredictability of an equine reaction to such things as sounds, sudden movements and unfamiliar objects, persons or other animals;
3. The equines response to certain hazards such as surface and subsurface objects;
4. Collisions with other equines, animals, people, and objects;
5. The potential of any participant to act in a negligent manner that may contribute to injury to the participant or others as failing to maintain control over the equine or to act within his or her ability.

I understand that injuries from such risks are common and ordinary occurrences associated with Equine Activities. I freely accept and fully assume all the risks and the possibility of personal injury, death and property damage being a participant. I acknowledge that it remains my sole responsibility to act in such a manner as to be responsible for my own safety and to participate within my own limits.

In consideration of the Host permitting my participation in the show, I together with my heirs, executors, administrators and assigns, (collectively called by Legal Representation) agree as follows:

1. To WAIVE ALL CLAIMS that I have against the Host;
2. To release the Host from any and all liability for any loss, damages, injury or expenses that I or my Legal Representation may suffer as a result of my participation in the show due to any cause whatsoever INCLUDING NEGLIGENCE ON THE PART OF THE HOST; and
3. To HOLD HARMLESS AND INDEMNIFY THE HOST from all liability for any property damage or personal injury to any third party resulting from my participation in the show.

And if the participant is minor, under the Age of 18 years:

In the event that the above named participant is under the age of 18, I _____ the Legal Guardian/Parent is executing this release and acknowledges on behalf of the participant in my capacity as Guardian and with the intent that this release and acknowledgment be binding in the infant participating for all legal purposes. Before I sign this waiver, I have read it. I state that I understand it. I am aware by signing this Waiver, I am waiving certain legal rights, which I might have against the Host, or, if I die, by signing this Waiver, I am waiving certain rights that my Legal Representatives may have against the Host, and which the infant participating has against the Host. In the event of my death or the death of the infant participating, by signing this Waiver, I am waiving all legal rights, which my Legal Representatives or the Legal Representative of the infant may have against the Host. I agree to indemnify the Host for any and all loss arising out of injury to the infant participating.
